## Graduation Requirements for the Class of 2029 and Thereafter

The Texas Education Code, Section 28.025(b) allows a student to graduate under the Foundation High School Program without earning an endorsement if, after the student's sophomore year, the student and the student's parent/guardian are notified of the benefits of graduating with an endorsement and the student's parent/guardian gives written permission for the student to opt out of an endorsement.

## Graduation Requirements for the Class of 2029 and Thereafter

Students must meet passing standards on the 5 End-of-Course (EOC) exams, in addition to earning all required course credits for their graduation plan, to earn a diploma. Students must meet all graduation course credit requirements and EOC requirements to be eligible for participation in the graduation ceremony.

## Financial Aid Application for High School Graduation

Completing a free application for federal student aid (FAFSA) is a graduation requirement. FAFSA and/or TAFSA must be completed before a student can receive a high school diploma. A parent or legal guardian may provide written notice to opt out their child. Students who are at least 18 years old may opt themselves out of the requirement.

<u>Instruction in Cardiopulmonary Resuscitation (CPR) and Automated External Defibrillator (AED)</u>
Students must receive instruction in CPR and AED at least once in grades 7-12 before graduation.

## Instruction on Proper Interaction with Peace Officers

Students must receive instruction in proper interaction with police officers at least once before graduation from high school.
