

- AP African American Studies Exam Pilot: Only schools participating in this year's pilot can order and administer the exam.
- Schools must begin the morning exam administration between 8 and 9 a.m. local time and the afternoon exam administration between 12 and 1 p.m. local time. The AP Physics C: Electricity and Magnetism Exam must begin between 2 and 3 p.m. local time. Schools in Alaska must begin the morning exam administration between 7 and 8 a.m. local time and the afternoon exam administration between 11 a.m. and 12 p.m. local time. The AP Physics C: Electricity and Magnetism Exam in Alaska must begin between 1 and 2 p.m. local time.
- AP coordinators are responsible for notifying students when and where to report for the exams. Early testing or testing at times other than
  those published by College Board is not permitted under any circumstances.
- AP coordinators should order late-testing exams for students who would like to take exams that are scheduled for the same time.
- AP Seminar and AP Research students must submit final performance tasks by 11:59 p.m. ET on April 30, 2024.
- On their AP Digital Portfolio, students participating in AP Computer Science Principles must submit their Create performance task as final by 11:59 p.m. ET on April 30, 2024.



Katy ISD Advanced Placement (AP) exams will be administered in person during the first College Board AP exam administration from May 6 - May 17 at students' home campus.







#### Test Day - Students should bring...

Several sharpened No. 2 pencils (with erasers) for completing multiple-choice answer sheets

Pens with black or dark blue ink for completing areas on the exam booklet covers and for free-response questions.

A watch that does not have internet capacity, does not beep, and does not have an alarm

Dress in layers/Bring a jacket

Up to two approved calculators for exams that need it. (See <u>apstudents.org/courses</u>)

A ruler or straightedge for Physics

School ID or Driver's License (MUST BRING DAILY)

SSD Accommodations letter from College Board (if applicable)



#### Test Day - Students should...



Bring a lunch if you have two tests on the same day.



Bring your school ID on test day!!!



Not make appointments on test days. College Board does not allow students to leave exams early. All students must be released at the same time.



Not bring cell phones or back packs on test days. No food or drink.





#### Unique AP ID

- When registering for My AP each student was assigned a unique ID that will be used to label exam materials for all tests taken.
- Students can access this unique ID from myap.collegeboard.org and then going to the registration tab under My AP Profile.





#### **Calculators**

## Students CANNOT bring...

Electronic equipment of any kind: Cell phones, smartwatches, or wearable technology of any kind, laptops, tablet computers, Bluetooth devices, portable listening or recording devices, cameras or other photographic equipment, devices that can access the internet, separate timers of any type, and any other electronic or communication devices.

Books, compasses, mechanical pencils, colored pencils, correction fluid, dictionaries, highlighters, or notes.

Rulers or straightedges on non-Physics exams, Protractors.


Scratch paper (notes can be made on portions of the exam booklets or, for Chinese Language and Culture and Japanese Language and Culture, on scratch paper provided by the proctor)

Reference guides, keyboard maps or other typing instructions.

Food or drink

Computers or Calculators (except as previously noted) Ear plugs or Clipboards. Clothing or shoes with subject-related information

Separate timers of any type and watches that beep or have an alarm





### Ensuring a Fair and Secure Testing Environment

The AP Program maintains strict test administration and test security procedures to prevent any testing incidents or improper conduct to maintain a fair and equitable environment.

Test security involves accounting for all secure materials and confidential student information **before**, **during**, and **after** each test administration.



# Examples of Misconduct/Breach of security - An AP teacher "interviews" students after the exam to gather information about specific multiple-choice questions or any questions. - A student takes an AP Exam on a day or at a time when it is not supposed to be administered.

#### Examples of Misconduct/ breach of security

- Attempting to give or give assistance
- Anyone (including, but not limited to, the AP coordinator, the proctor, school staff, members of the media, and students) takes photos in the exam room during an exam.
  - Examples include viewing or capturing images with a cell phone on test day or being caught with a "cheat sheet" containing test content, answer keys, or other content that would provide an unfair advantage.



# Consequences of Violating **Security Policies**

- A breach of exam security could result in the invalidation of exam scores for individual students or for all students taking that particular exam at the school.
- Any breach places the campus in jeopardy of not be allowed to offer AP exams in the future and held liable for financial damages incurred by College Board.
- The College Board will prohibit individuals from taking the SAT, SAT Subject Tests, or AP Exams when we conclude they have deliberately gained or attempted to gain or share an unfair advantage on any College Board test, or otherwise threatened the integrity of the test.



- No one, other than the students taking the exam, is allowed access to multiple choice questions at any time.
- Students seal their multiple choice test booklets at the end of the administration and are not permitted to share information about these questions with anyone (including their AP Teachers), after the exam is over.
- Multiple Choice Test content may never be shared, copied in any manner, or reconstructed by students or teachers after the exam.

#### **Discussion of Exam Content**

The Section I, Part B, booklet for European History, U.S. History, and World History: Modern Exams only, and the Section II booklet for all exams contain free response content, may never be copied

- The only free-response items that may be discussed are the items that College Board releases on their website, two days after the regular exam administration.
- Not all items are released. If someone is in doubt, then items should NOT be discussed.

Late or Alternate exams will never be released and may never be discussed in any way.

Violation of these rules results in immediate invalidation of the student's scores.



# COLLEGE BOARD WILL AUTOMATICALLY CANCEL YOUR EXAM SCORE IF YOU ARE DISCOVERED DISCLOSING THROUGH ANY MEANS THE FOLLOWING:

- multiple-choice content for any exam (this content is never released and may therefore never be discussed)
- free-response content from an alternate (late-testing) exam
- free-response content from a regularly scheduled exam within 2 days of its administration
- free-response content that is not released on the College Board website 2 days after the regularly scheduled exam administration
- This means that something you may not have intended as a violation, like casually talking about a multiple-choice question with your friends or your teacher during the exam break or discussing a free-response question right after the exam, can actually result in having your score canceled.
